

Expanded goal tracking

This report was introduced in DAISY 5.0 and is so helpful we thought it deserved another shout out.

Our AR Activity pie chart shows charge, payment and adjustment activity for a selected month. The totals can be viewed and filtered by billing provider based on service date.

Double-clicking on a "wedge" of the chart expands the corresponding section. For example, double click on the Payment wedge and you see a new pie showing only payment activity. This provides a clear visual of how the majority of your payments are being received. The pie chart wedges are color coded according to the legend on the right side of the window.


